Once we have received data from our Regents, 3-8 ELA, Math, Science and A.P. exams, teachers, principals and district administration review the data and disaggregate the data by subgroup. We set a goal that all students will meet or exceed a 65% threshold on each Regent examination. District administration works with principals and teachers to be aware of standards that must be addressed and learned. All students with disabilities and English language learners are identified as well as the modifications and accommodations that they require. In addition to the review of State exams and class administered formative assessments, teachers work in grade level and departmental teams with administration to review student work and local assessment data, on a regular basis, through use of Star Renaissance Math and Star Renaissance Reading universal screeners and progress monitoring assessments. Data for students at/or above grade level is reviewed 3 times a year. Students below benchmark have their data reviewed monthly in order for teachers to make instructional changes. Students well below benchmark have their performance data reviewed biweekly in order to determine growth and changes to interventions, if needed. This data is used to help inform instruction and student learning goals at the individual level as well as instructional goals across grade levels and across departments.
