- f. Provide ninth grade students opportunities for career exploration in conjunction with Freshman Seminar teachers
- g. 10th grade students will complete the Career Cluster Finder and the Interest Profiler on Naviance student
- h. Putnam Northern Westchester (PNW) BOCES presentation for 10th grade students
- i. Annual field trip opportunity to PNW BOCES to explore programs
- j. Each student will maintain a career portfolio through Naviance
- k. Provide juniors opportunities for career exploration in conjunction with COMPASS teacher and through junior interview meetings

- ➤ Early intervention with students at risk academically, socially, and emotionally
